

Our Agreement - Terms and Conditions (Year 4 Course 20/21)

Payment

The total course fee is £1,680 (This fee is reduced to £1580 for students enrolled on the Bradley Tuition Year 3 course). The client agrees to pay a non-refundable registration fee of £200 in order to enrol their child's place on the course. The client agrees to pay the remaining balance in monthly instalments of £185p/m, via standing order.

Service Provided

Bradley Tuition Centre LLP will provide tuition that comprehensively covers the four key areas found in 11+ examinations. These key areas are: Numerical Reasoning, Verbal Reasoning, Non-Verbal Reasoning and English. For these areas, all classwork and homework materials will be provided and are included in the cost of the course. Please note the course does not cover creative writing. The term 'client' refers to the parents, guardians and students who are parties to this agreement.

All materials and equipment provided by Bradley Tuition Centre LLP are for the sole use of students enrolled on the course. The replication or re-use of the course material is strictly forbidden.

Communication

A successful year of 11+ tuition involves effective communication between parent, child and tutor. This agreement requires an undertaking by parents and/or guardians to ensure that set homework is completed on schedule. It is a condition of this agreement that the client accepts that all homework will be completed to the best of the child's ability and will be marked before each class. The scores must also be uploaded on the online portal, every week. If Bradley Tuition Centre LLP determine that the client is not fulfilling these conditions, Bradley Tuition Centre LLP reserve the right to terminate the agreement.

Accountability

All clients acknowledge that Bradley Tuition Centre LLP cannot guarantee exam success.

Location

Bradley Tuition Centre LLP reserves the right to change the venue, without notice, to any suitable premises within an 10 mile radius of the agreed location.

Remote Learning

Bradley Tuition Centre LLP reserves the right to make decisions on how classes are conducted with reference to the Covid-19 outbreak. The decision on how to operate the classes will be solely down to the judgement of Bradley Tuition Centre LLP. Bradley Tuition Centre LLP reserves the right to conduct all classes online, if required

Lessons may be recorded for training and content purposes.

By enrolling a child onto a course the client is agreeing to attend virtual sessions where necessary. Parents/Guardians must have the appropriate technology (a functioning laptop with webcam and microphone), to make this possible.

If a 'return to normal' is permitted, the client must be happy to change their lesson slot to the time outlined by Bradley Tuition. This time will be similar to your usual slot but will not be exactly the same.

If a switch from remote learning to classroom based learning is decided, the client accepts that remote learning will no longer be an option.

Jurisdiction and Confidentiality

Missed Lessons (Classroom Sessions)

If arranged in advance, pupils may occasionally swap into an alternative class, if available. This swap service is available to all pupils and is subject to fair usage. No reimbursement is available if your child misses any of the teaching sessions. Please note that this includes both sickness and holidays.

Missed Lessons (Video Calls)

If arranged with at least 48 hours notice, we will allow each pupil to swap their one-to-one video lesson slot once each term. If you miss the session without providing 48 hours notice, you will not be offered a rescheduled lesson.

Termination of Tuition
